The said Bertie Reginald Menteith BREBNER is an Engineer Royal Indian Marine and resided when not at sea at 51 Whyke Lane Chichester in the County of Sussex, but his present address is unknown. Your Petitioner and her said husband are both domiciled in England. Your Petitioner is now residing at 4 Inglemere Road Tooting Junction aforesaid."

"That after her said marriage your Petitioner lived and cohabited with her said husband at 25 Camden Hill Road Upper Norwood 12 Bloom Grove West Norwood and 28 Whiteley Road Upper Norwood in the said county of Surrey and at 51 Whykes Lane, Chichester aforesaid and that your Petitioner and her one child and no more to wit Bertie Alexander Gorden Menteith BREBNER born on the 8th day of November 1898."

"That since the celebration of the said marriage the said Bertie Reginald Menteith BREBNER committed adultery with some woman unknown and contracted a venereal disease and that in or about the month of June 1901 the said Bertie Reginald Menteith BREBNER knowingly wifully and recklessly communicated such venereal disease to your Petitioner and was thereby guilty of cruelty towards her."

"That on a subsequent occasion the said Bertie Reginald Menteith BREBNER committed adultery with some woman unknown and again contracted a venereal disease; and that in or about the month of June 1902 the said Bertie Reginald Menteith BREBNER knowingly willfully and recklessly communicated such venereal disease to your Petitioner and was thereby guilty of cruelty towards her."

"That in the said month of June 1902 the said Bertie Reginald Menteith BREBNER insisted on having a connection with your Petitioner notwithstanding the her periods had come on and was thereby guilty of cruelty towards her; about the said time the said Bertie Reginald Menteith BREBNER insisted on having excessive sexual intercourse with your Petitioner to the detriment of her health."

"In or about the month of October 1902 the said Bertie Reginald Menteith BREBNER continually swore at your Petitioner and ordered her about like a servant although she would try to do her utmost for him and deprived her of her position as housekeeper and this treatment (she being in a very weak state) upset her nervous system and injured her health and he was thereby guilty of cruelty towards her."

"That in or about the month of November 1902 your Petitioner entered the sitting room at No. 51 Whyke Lane Chichester aforesaid where she and her said husband were living and found the said Bertie Reginald Menteith BREBNER sitting astride her sister the discovery of which in her weak state of health caused your Petitioner to have a kind of fit and the said Bertie Reginald Menteith BREBNER was thereby guilty of cruelty towards her."

"That in or about the month of July 1903 at No. 51 Whyke Lane Chichester aforesaid the said Bertie Reginald Menteith BREBNER violently pulled your Petitioner by the hair giving great pain and causing her to weep and was thereby guilty of cruelty towards her."

"In or about the month of March 1903 at 51 Whyke Lane, Chichester, aforesaid the said Bertie Reginald Menteith BREBNER forcibly and in spite of your Petitioner's remonstrances committed the abominable act of sodomy upon your Petitioner and thereby seriously hurt her and was again guilty of a similar offence in or about the month of May 1903."

"That ever since the said marriage of the said Bertie Reginald Menteith BREBNER has continually failed to supply your Petitioner with the necessary money to buy food and coals for herself and her child notwithstanding his ability to do so by reason of which her health has suffered."

"That on a large number of occasions since the said marriage the said Bertie Reginald Menteith BREBNER has returned home drunk and knocked the furniture about and swore at your Petitioner causing her to live in great fear of him which has upset her nervous system and thereby affected her health."

"That on numerous occasions since the said marriage the said Bertie Reginald Menteith BREBNER has used the most filthy language to your Petitioner when having connection with her."

"That no previous proceedings in reference to the said marriage have taken place in the Divorce Division of the High Court by or on behalf of either party to the said marriage your Petitioner humbly prays that your Lordship will be pleased to decree that the marriage of your Petitioner with the said Bertie Reginald Menteith BREBNER be dissolved."

"That your Petitioner have the custody of the child Bertie Alexander Gorden BREBNER."

"That the said Bertie Reginald Menteith BREBNER may be condemned in the costs of these proceedings and that your Petitioner may have such further and other relief in the premises as to your Lordship may seem meet."

But incredulous as it may seem, the Petition for Divorce was dismissed and she was still shown as living with husband Bertie and son Bertie in the 1911 census. I wonder (and this is merely speculation) if Bertie's family intervened with a cash settlement to avoid scandal.
