

1. **Charles Brebner** #4313 b. c 1756, Aberdeen Old Machar, ABD, SCT,¹ occupation Gardener, North Rubislaw, m. 01 NOV 1800, in Aberdeen Old Machar, ABD, SCT,² **Isabella Ross** #4314, b. c 1772, Aberdeen?, ABD, SCT, d. 23 MAR 1852, Aberdeen, ABD, SCT, buried: Aberdeen Spital, ABD, SCT.³ Charles died 26 JUN 1848, Aberdeen, ABD, SCT, buried: Aberdeen Spital, ABD, SCT.⁴ Shown in City Directory 1836-1837, 1840-1841 (lived at Fountainhall in early 1800s) 1841: Lived at Fountainhall, Aberdeen Old Machar, occupation shown as "Independent", born parish. Had will. **Isabella**: 1841 census: Age shown as 68, born Aberdeen 1851: Lived at Rubislaw, Aberdeen Old Machar, farmed 3 acres with three daughters at home.

- i **Charles Brebner** #10477 b. 27 DEC 1794, Aberdeen?, ABD, SCT,⁵ occupation Gardener's Labourer*, d. 09 NOV 1856, Gallowgate, Aberdeen, ABD, SCT.⁶ Note that his father's will refers to him as "sometime Merchant in Aberdeen".
 - ii **Margaret Brebner** #4316 b. 20 MAR 1801, Aberdeen. ABD, SCT, 31 MAR 1801, Aberdeen Old Machar, ABD, SCT,² d. 07 JAN 1845, Aberdeen, ABD, SCT,⁷ buried: Aberdeen Spital, Aberdeen, ABD. age shown as 35 in 1841, no occupation
 - iii **Jane Brebner** #10512 b. 1803, Aberdeen Old Machar, ABD, SCT, 18 JAN 1803, Gilcomston Church, Aberdeen, ABD, SCT,⁸ d. infancy.
 - iv **Jane Thomson Brebner** #4315 b. MAR 1805, Aberdeen, ABD, SCT, 17 MAR 1805, Aberdeen Old Machar, ABD, SCT,² occupation Domestic Servant, d. 24 MAY 1864, 19 Chapel St., Aberdeen, ABD, SCT,⁹ buried: Aberdeen Spital, Aberdeen, ABD.³ unmarried at time of death
 - v **Alexander Brebner** #4320 b. c 1807, Aberdeen, ABD, SCT, d. AUG 1809, Gilcomston, Aberdeen, ABD, SCT, buried: 21 AUG 1809, Spital Burial Ground, Aberdeen, ABD.¹⁰ name is recorded on memorial in St. Peter's Cemetery, Aberdeen, but both he and his sister Janet are recorded in the Spital Burial Ground Registers.
 - vi **Janet Brebner** #4321 b. c 1812, Aberdeen, ABD, SCT,¹¹ d. 1819, Aberdeen, ABD, SCT, buried: 09 AUG 1819, Spital Burial Ground, Aberdeen, ABD, SCT.¹²
 - vii **Isabella Brebner** #4317 b. c 1812, Aberdeen ?, ABD, SCT, m. 29 SEP 1838, in Aberdeen Old Machar, ABD, SCT,¹³ **William Henderson** #35654, occupation Gardener. Isabella died 17 JAN 1850, Aberdeen, ABD, SCT,¹⁴ buried: Spital Burial Ground, Aberdeen, ABD. Note that her husband is not mentioned on her family gravestone... **William**: 1838: Was gardener at Westburne, Aberdeen at time of marriage. (No children found IGI...) 1841: Not located Aberdeen parishes (SEP 2006); ancestry.com
 - viii **Anne Brebner** #4318 b. c 1814, Aberdeen ?, ABD, SCT, occupation House Servant 1851, d. 15 APR 1865, Aberdeen, ABD, SCT,¹⁵ buried: Spital Burial Ground , Aberdeen, ABD. 1851: Lived with widowed mother and sisters Jean and ELizabeth at Rubislaw.
 - ix **Elizabeth Brebner** #4319 b. c 1819, Aberdeen ?, ABD, SCT, occupation Domestic Servant, d. 15 MAR 1896, 89 Chapel St., Aberdeen, ABD, SCT,¹⁶ buried: Spital Burial Ground, Aberdeen, ABD.¹² Unmarried. See also Reg. Corr. Entries, p 123, Mar 23rd, 1896.
